Schedule days approximate

- DAY 1: Arrive in **Warsaw**, coach transfer to five-star hotel, welcome presentation by David Irving
- DAY 2: Travel by coach to resort hotel in Mrągowo in Masuria, the beautiful lake district of East Prussia. Anticipatory presentation by David Irving: *"Himmler and the SS. His Role in the* July 20, 1944 Bomb Plot"
- DAY 3: Visit Himmler's bunker headquarters, **Hochwald**, in the forest outside the Polish village of Pozezdrze
- DAY 4: Visit Hitler's famous headquarters **Wolf's Lair**, in Kętrzyn (**Rastenburg**)

- DAY 5: Return to **Warsaw** by coach. Showing of movie, *Downfall*, with commentary. Presentation on Treblinka by an expert on Himmler's Operation Reinhardt
- DAY 5-8: Travel by coach to the controversial Operation Reinhardt sites Maidanek, **Sobibór, Belzec, and Treblinka**.
- DAY 8: OPTION 1 Sightseeing in Warsaw with local expert guide to visit wartime resistance sites; or OPTION 2 individual shopping or sightseeing in Warsaw. Farewell reception with dinner
- DAY 9: Departure from Warsaw

Participants make their own travel arrangements e.g. to Riga, and from Warsaw, Poland. Actual dates and sites are separately notified (for security). You should inform us of arrival plans in good time, particularly if your destination is not Warsaw's Chopin airport, so that we can arrange your transport to the hotel. The price (see page 3) for the tour includes travel within Europe including transfers to and from the airport, all hotel accommodations and meals (including breakfast), including two formal dinners, and entry fees to historic sites. Guests will as usual be responsible for their own hotel incidentals (e.g., phone charges, additional room-service orders, etc.).

Hints on Travel to (Latvia and) Poland

Passport and visa requirements: EU citizens require a passport to fly to Latvia or Poland, but not if they travel by other means (when they should however bring some form of official photo-identification, *e.g.* driving license). Guests from Britain don't need a visa but will need a passport.

Non-EU citizens, including citizens of the United States, Canada, and Australia, are required to have a passport that is valid for at least three months for their stay in Poland, but do not need any special visas. If you do not already have one please apply for your passport at least 6-8 weeks before travel to ensure that you receive it in time. When you arrive at the airport, you may be asked for a copy of your flight itinerary showing your return flight and you will need to be able to provide the address of where you will be staying for the first night (which we will provide to registered guests).

Minor points: It can be quite hot in the late summer. Bring some long-sleeved clothes in case of bugs, and shoes suitable for forest paths. Most Latvians and Poles, especially the younger generations, speak English; however, pocket phrasebooks may come in handy. Older mobile phones brought from outside Europe may not work within Poland. You may change currency at many locations in Warsaw - or smaller amounts with us - and major credit cards are widely accepted. Poland's currency is not the euro, but the złoty (pronounced zwotty); and the exchange rate is typically favourable to the dollar, pound, and euro. Salt and pepper pots are opposite to normal.

In Poland toilets are sometimes free but often not, and a one- or two-złoty coin (the latter, PLN2, is bimetallic) is required for a machine or tip. We will provide a few coins for our arriving guests. The signs to look for are toalety (toilets) or lazienka (pronounced wazhenka), bathroom. The sign for males is an inverted triangle ▼ and for females a circle ●. We cannot offer a helpful logic for these.
